Pursuant to Republic Act No. 8295 or the "Alternative Dispute Resolution Act of 2004" and Executive Order No. 97, s. 2012, an ADR Committee is hereby created in the PRI. The said committee shall have the following functions:

- a. coordinate with the Department of Justice Office of Alternative Dispute Resolution (DOJ-OADR) and relevant Department of Transportation offices, and develop rules, regulations, and procedures to define and implement ADR policies in the PRI;
- develop guidelines for the establishment, design, management, conduct, and monitoring of ADR programs to streamline, improve, and render more efficient the delivery of dispute resolution services in conformity with the standards set by the DOJ-OADR and internationally accepted best practices;
- c. lead in the implementation of ADR policies in the PRI;
- d. monitor and evaluate the PRI's use of ADR, and require compliance with any standards or guidelines issued by the DOJ-OADR;
- e. prepare annual reports on the status of ADR use in the PRI, and submit the same to the DOJ-OADR; and
- f. perform such other functions as may be necessary or appropriate to carry into effect the purpose of this Order.
