SUBJECT : AN ORDER REPEALING PRI OFFICE ORDER NO. 13, s. 2022 AS REGARDS THE COMPOSITION OF THE CONTINUING PROFESSIONAL DEVELOPMENT (CPD) COMMITTEE

To ensure that the PRI complies with Republic Act No. 10912 or the “Continuing Professional Development Act of 2016” and Professional Regulation Commission (PRC) Resolution No. 1032, s. 2017 as a PRC-accredited CPD points provider, a CPD Committee is hereby established with the following duties and functions:

- a. submit application forms to the PRC relative to the conduct of the PRI’s training courses that may be considered for CPD points;
- b. monitor PRI trainee-professionals who are qualified to receive CPD points and report them to the Certification and Accreditation Division for the issuance of Certificates of Appearance with Earned CPD Points or instructions for personal application with the PRC, whichever is applicable;
- c. maintain a database of qualified PRI trainee-professionals containing all relevant information;
- d. coordinate with the PRC on all matters relative to the PRI’s application and submission of reports, documents, and other papers;
- e. develop reports, documents, and other papers, and submit the same to the PRC; and
- f. perform such other functions as may be necessary or appropriate to carry into effect the purpose of this Order.

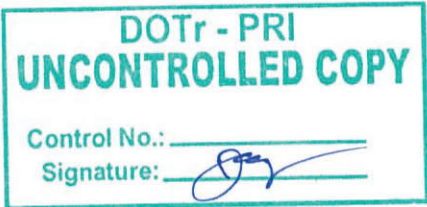

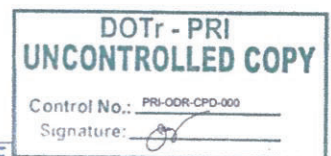
