In view of the exigency of service and to continuously maintain and ensure workplace inclusivity and diversity and uphold policies promoting GEDSI in the Philippine Railways Institute (PRI), a GEDSI Committee is hereby established. The said committee shall have the following functions:

- a. develop and implement GEDSI/GAD-related policies, guidelines, and strategies aligned with national frameworks, promoting gender equality, disability inclusion, and women's empowerment within PRI.
- b. integrate GEDSI perspectives into all PRI programs, projects, and activities, conducting gender analysis to address gender-based gaps and disparities.
- c. conduct workshops, learning sessions, capacity building activities, and awareness campaigns to enhance the gender sensitivity and awareness of PRI staff and stakeholders.
- d. advocate for gender-responsive planning, monitoring systems, and foster a discrimination-free work environment.
- e. collaborate with external organizations and raise awareness about GEDSI in the railway sector.
- f. prepare periodic reports on the GEDSI Committee's activities, achievements, and challenges and maintain comprehensive documentation of GEDSI-related initiatives and outcomes.
